INSTRUCTIONS TO THE TENDERERS AND TERMS AND CONDITIONS

- 1. The quotation should be submitted in a *SEALED ENVELOPE* superscribing the tender number and due date of opening.
- 2. An EMD of Rs.10000/- may be submitted by way of bank remittance remitting the amount to our bank account. (Account no: 57059896404; Account Name: National Centre for Earth Science Studies (NCESS); IFSC Code: SBTR0000581; MICR Code: 695009036; Bank: State Bank of Travancore, Akkulam, Trivandrum). The remittance should reflect in our accounts at or before the time of submission. The late remittance will not be valid. Exemption from EMD will be allowed for organizations registered with Central Purchase Organization, National Small Industries Corporation (NSIC) or MoES, Govt. Of India, if the claim is supported by relevant documents. <u>The bank details for the refund of EMD should be furnished along the bid.</u>
- **3.** The AMC will be comprehensive and it will include all spares, labour, servicing, gas charging etc. If the equipment has to be taken to their service centre, the transportation cost, loading and unloading will be borne by the AMC provider.
- 4. <u>The AMC period will be 2 years</u> from the date of issue. The rate quoted should be for two years.
- 5. Quarterly preventive maintenance should be done on all ACs.
- **6.** The ACs with unit warranty will automatically come under AMC upon the expiry of this unit warranty.
- 7. The ACs having compressor warranty also should be serviced by the AMC provider. If a compressor under warranty has any problem, the AMC provider should give it in writing to the EA&M section so that they can take up the matter with the manufacturer/ supplier. The AMC provider should also inspect the replacement/repair in such cases. Once the compressor warranty expires, such ACs will fully come under the AMC of the service provider.
- 8. <u>The bidder should provide copies of at least 3 AMC orders issued to them by reputed</u> <u>organisations, each containing at least 7 ACs with letter of satisfaction from the customers.</u>
- 9. The bidder should have proper <u>office in Trivandrum</u> city limits.

- **10.** The service provider should attend the call within a reasonable response time of 6 8 working hours.
- **11.** Payment will be made on deferred quarterly basis against invoices.
- 12. The preference will be given for the firms quoting for all ACs in the list, subject to reasonableness of the amount. A bidder quoting for one make should definitely quote for all the ACs of that particular make. Otherwise, the bid will not be considered at all.
- **13.** The Purchaser reserves right to accept any tender in part or full without assigning any reasons. The enquiry is not a commitment and the purchaser reserves the right to reject or cancel any or all offers.
- 14. The price should be shown inclusive of taxes for easy comparison. The tax rates and methods used should be mentioned separately. If the government increases the tax rates subsequently, the corresponding increase in the rates will be admitted.
- **15.** The EMD of disqualified bidders will be refunded upon finalization of the rate contract.
- **16.** The successful bidder must deposit Rs 30000/- as security deposit which will be refunded at the end of the AMC period without any interest. The EMD will be refunded upon receiving the security deposit and the letter of acceptance of AMC order.
- **17.** The Centre will have the authority to forfeit the security deposit in case of any failure on the part of the service provider to provide the required service and the decision of the Centre on this matter will be final.
